



# CONDITIONS OF ENTRY JUBILEE PARK STADIUM

## Introduction

Patrons and visitors attending Jubilee Park Stadium (Venue) including the outdoor netball courts must comply with all laws, regulations, directions and policies issued by any government authority or Frankston & District Netball Association Staff (or delegate) while this facility is managed by Frankston & District Netball Association (FDNA), by authority of Frankston City Council.

For the comfort, safety and enjoyment of all patrons, staff and participants, entry to this venue is subject to the following Conditions of Entry.

## CONDITIONS

### 1. Use of stadium

The Venue (including all areas, fixtures, fittings, buildings and improvements) should at all times be used for appropriate and approved purposes.

You are responsible for your own property and FDNA will not be liable for loss, damage to or theft of any property brought to the Venue.

### 2. Prohibited Items

The following items are not permitted to be brought in the Venue:

- ANY form of bicycle, scooter, skateboard and/or rollerblade/skates (or similar)
- Any food or drink other than water or other drinks specifically for the purpose of hydration whilst participating in sport
- Illegal substances, including controlled, dangerous or illicit drugs
- Incendiary devices, including flares, fireworks and smoke bombs
- Firearms and explosives, chemical, radioactive or biological substances
- Laser lights
- Alcohol
- Animals (other than identified assistance dogs)
- Chairs/stools
- Glass (including bottles)
- Any other item that in the opinion of management, could cause harm or public nuisance

### 3. Alcohol

The indoor venue is partially licensed and as such, the following provisions apply:

- Alcoholic beverages must not be taken into or from the venue
- Intoxicated persons will be refused entry and/or evicted from the venue(s)
- Alcohol may only be consumed in designated areas and at times authorised by FDNA
- It is an offence for minors to purchase or consume alcohol, or for a person to supply alcohol to a minor.

- Breaches of these laws may result in eviction from the venue and the persons being reported to the Police (penalties apply under the Liquor Control Reform Act 1998).

#### 4. Smoking

Smoking and/or vaping is not permitted inside the venue or anywhere on the grounds managed by FDNA. FDNA reserves the right to ask smokers to relocate to a designated smoking area.

#### 5. Restrictions on Entry

FDNA reserves the right to refuse entry to any person. This will include observing any temporary or permanent bans of spectators/members of hiring user groups.

#### 6. Ejection from Venue

*A person may be ejected from the venue where that person:*

- Breaches the Child Safety Standards and/or
- Breaches the Victorian Government Fair Play Code or Netball Australia Member Protection Policy or Netball Victoria Codes of Conduct and/or
- Uses foul or abusive language or makes discriminatory or threatening remarks or gestures and/or
- Is deemed by FDNA Staff to be displaying offensive, disorderly or unlawful behaviour and/or
- Enters the venue or other restricted internal area without proper authorisation; and/or
- Fails to comply with these conditions of entry or a lawful request from FDNA Staff and/or
- Any person/s identified by FDNA Staff to be engaged in any practice considered to be involved with transmitting information from sporting events for the purpose of gambling

*\*\*No fees will be refunded if a person is ejected from the venue\*\**

#### 7. Other Conditions

- Patrons & visitors are advised that the venue is fitted with CCTV electronic surveillance and patrons may be filmed in any public area of the venue (refer CCTV Policy)
- Patrons and visitors enter the venue at their own risk and FDNA Management has no liability for any damaged, lost or stolen property nor for any other loss, damage or injury suffered by any patron, whether in contract, tort or statutory liability to the full extent permitted by law.
- Acknowledge that you may be filmed, televised, photographed or otherwise recorded by FDNA or FDNA approved representatives. FDNA owns all rights in these images and material, including without limitation intellectual property rights, and has the right to reproduce, use or license the use of these images and material as it sees fit without your further approval being required.

- If you suffer any injury or illness, you agree that a representative of FDNA may provide or facilitate evacuation, first aid and/or medical treatment at your expense and that your acceptance of these Conditions constitutes your consent to such evacuation, first aid and/or medical treatment.
- Hiring users of the Venue may have additional restrictions or conditions imposed, at the sole discretion of FDNA.
